In 2021 an extension was realized, which includes a new double garage with workshop and cellar on the ground floor and a spacious bedroom on the second floor. On the second floor there are 3 more bedrooms and a wc with bathroom. Downstairs there is a spacious guest room, wc and living room with kitchen from which we reach the terrace, which is lined with Mediterranean travertine. The renovation of the terrace took place in 2021. It is heated by underfloor heating via a gas boiler. It is situated on a generous plot of 981 m² with a total built-up area of 206 m². In the garden you can spend your free time in the pleasant relaxation area with barbecue, which in the summer months is intertwined with beautiful wisteria. The house is ideal for a family looking for a combination of comfort and natural surroundings.

DISPOSITION

At the entrance there are stairs to the upper floor. Through the entrance hall we get to the kitchen connected to the living room, from which we get to the terrace. From the entrance hall we can also reach the guest room or the double bedroom. Next to the stairs there is a toilet. From the double garage we get to the workshop where there is also a toilet, this part of the house is basement. On the second floor there is a toilet with bathroom and a storage room with access to the attic. Through a wide corridor we get to the room adjacent to the bedroom. Through the corridor we then get to the other 2 rooms. In the house there is a double garage, from which we get to the basement workshop/storage. In front of the garage you can conveniently park another 2 cars. The garden can be accessed from

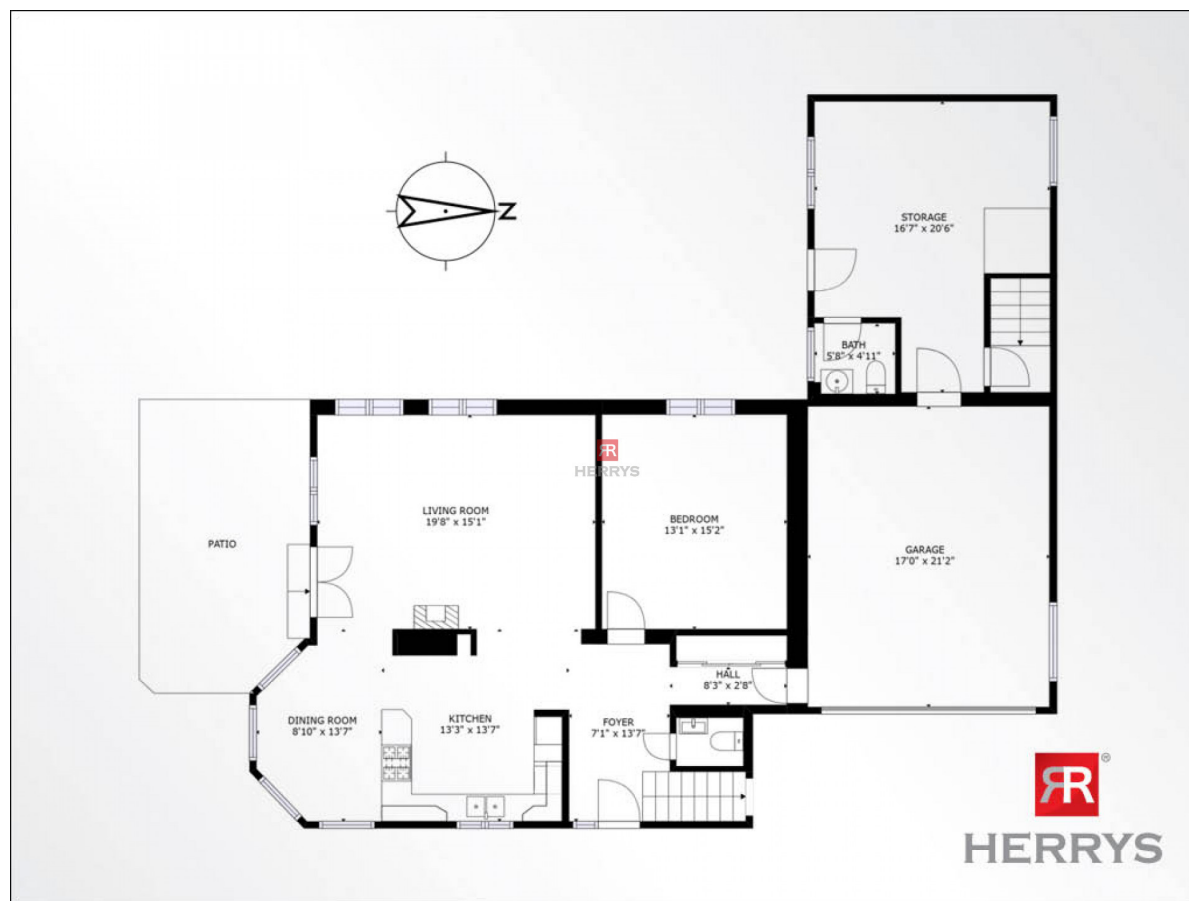

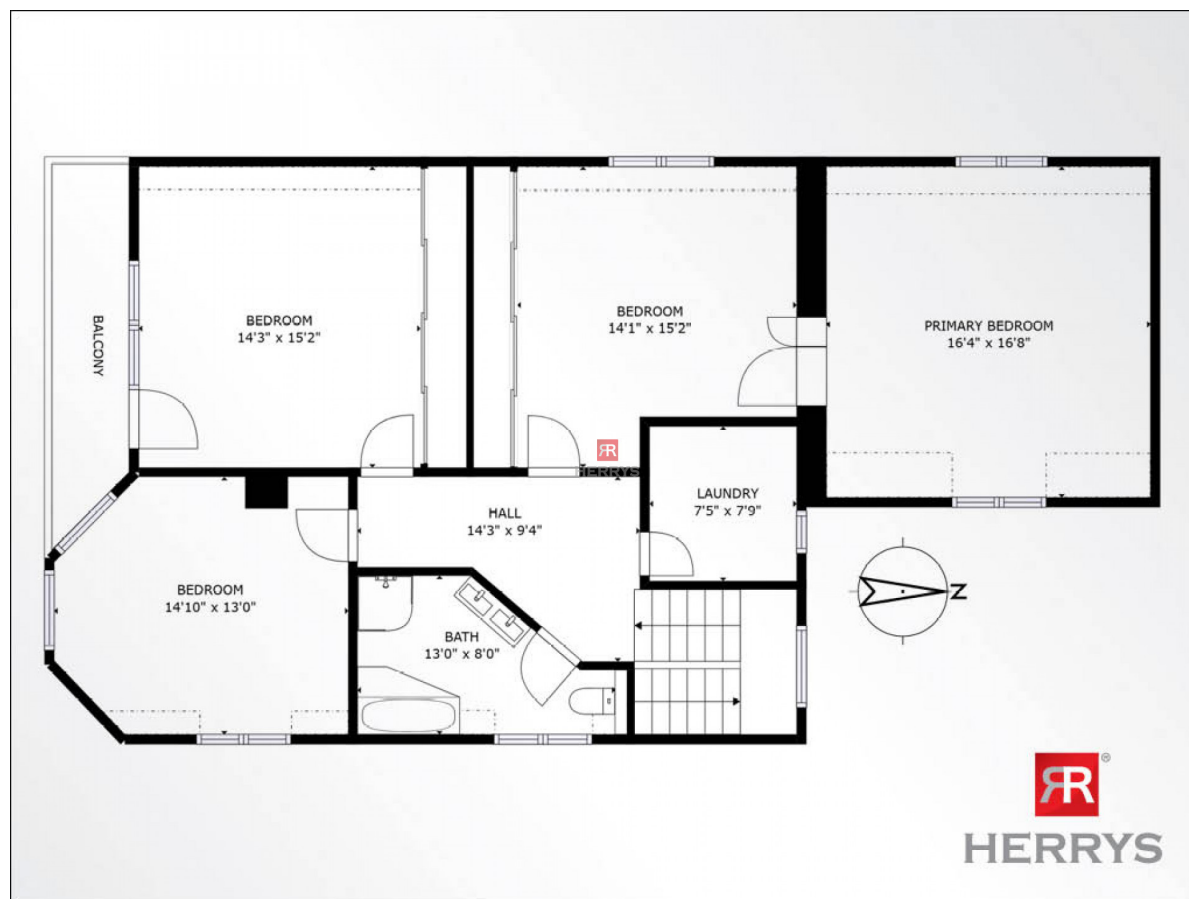
