It consists of a basement of 181 m<sup>2</sup> with five rooms and a bathroom with toilet, an elevated ground floor of 148 m<sup>2</sup> consisting of four offices, a bathroom with toilet and a spacious terrace of 21 m<sup>2</sup>, and an attic with a usable area of 97 m<sup>2</sup>, where there are two rooms, a kitchen, a bathroom with toilet and a terrace of 21 m<sup>2</sup>.

The premises provide security in the form of an alarm and security bars on the windows and doors, which are anchored into the lining. There are **4 parking spaces in the courtyard**.
