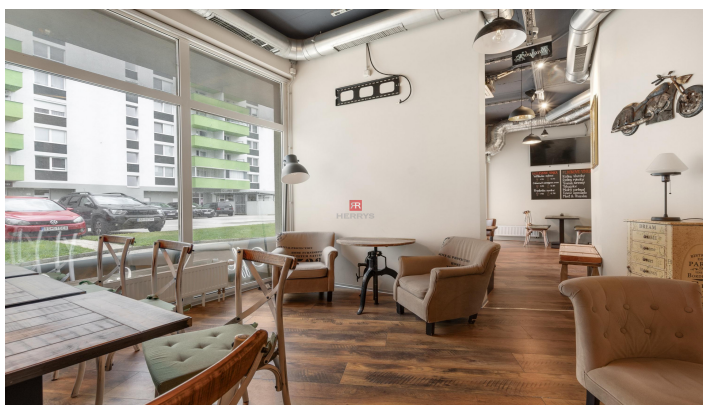
At the same time, they are located near the Little Carpathians, which ensures sports enjoyment and quick access to nature.

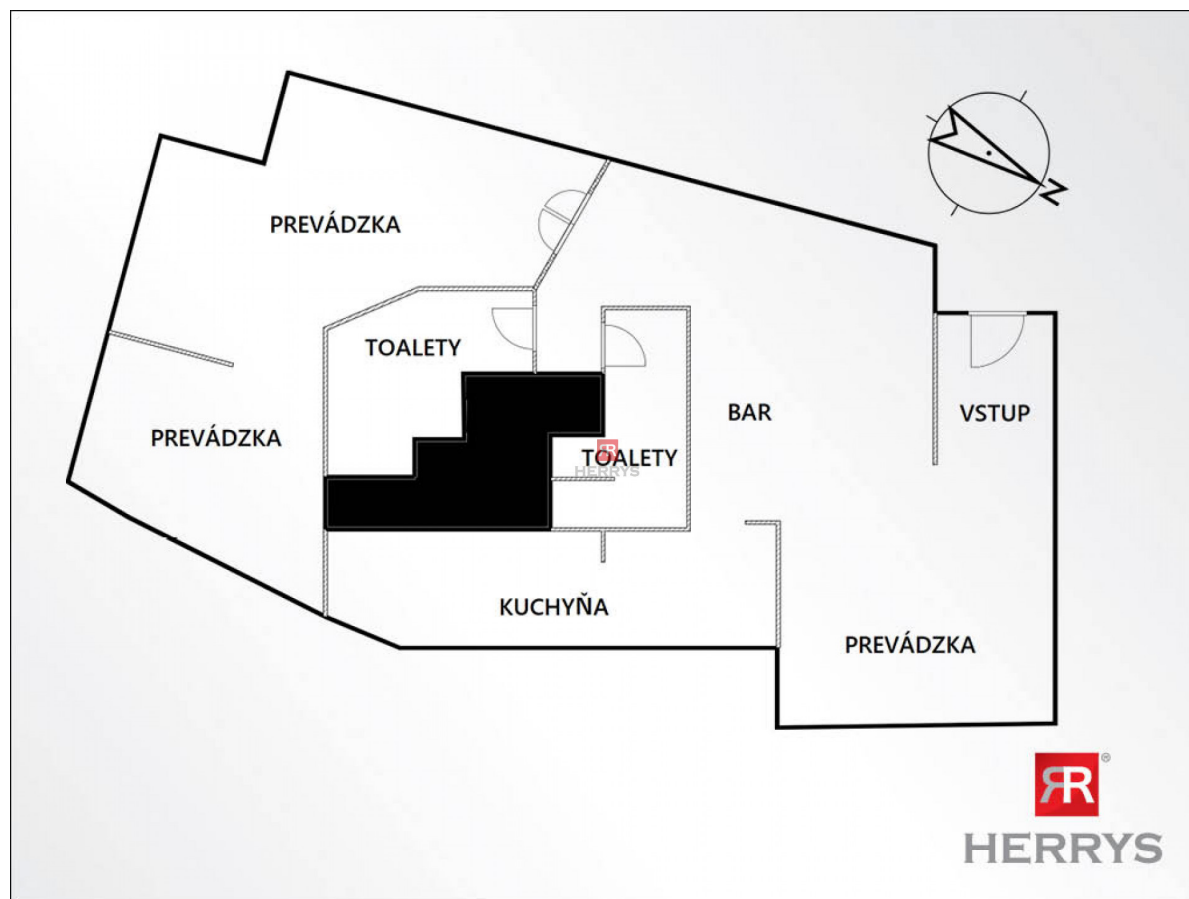
